# 1. PROJECT PURPOSE

The purpose of this Request for Quotation (RFQ) invites suitably qualified and experienced service providers to submit quotations for the supply and installation of fencing at the Dundonald Small Industrial Park.

The appointed service provider will be responsible for delivering high-quality work in accordance with the project specifications, applicable standards, and the required timelines.

# 2. SERVICE PROVIDER'S TERMS OF REFERENCE

The Mpumalanga Economic Growth Agency (MEGA) seeks to engage the services of a suitably qualified and experienced service provider for the **supply and installation of clearview security fencing** at the **Dundonald Small Industrial Park**. The scope of work includes excavation, disposal, concrete footings, and installation of fencing panels and access gates as specified in the project details.

A formal **Service Level Agreement (SLA)** will be entered into with the appointed service provider, outlining the full scope of work, deliverables, timelines, and contractual obligations related to the project.

These **Terms of Reference (ToR)** serve as a framework for the evaluation and appointment process, ensuring alignment between MEGA's project requirements and the technical capabilities, compliance, and qualifications of the service provider. The successful bidder's proposal will form the basis of the SLA to be concluded with MEGA.

# 3. PROPOSAL REQUIREMENTS

# GENERAL SCOPE OF WORK

This project entails the complete supply and installation of a clearview security fence at the Dundonald Small Industrial Park. The work includes all excavation, disposal, concrete footing, and installation of both fencing panels and access gates. The contractor will be responsible for all materials, labour, equipment, and logistics to deliver a secure, durable, and aesthetically consistent perimeter fencing solution in accordance with the specifications provided.

The Service provider must be CIDB GRADE 2 SQ OR GB accredited or Higher, attach supporting documentation

### 4. EXPECTED DELIVERABLES

The appointed service provider is expected to deliver the following:

- 1. Excavation of Post Holes.
- 2. Material Disposal: Removal and dumping of surplus soil/material from excavations at a location to be sourced by the contractor.
- 3. Water Management: Ensure excavations remain free from water ingress, excluding natural subterranean water.
- 4. Backfilling: Proper backfilling of trenches after post and concrete installation.

- 5. Concrete Works: Supply and cast reinforced concrete directly against excavated surfaces for fence footings.
- 6. Fence Installation: Supply and install Clearview fencing panels.
- 7. Gate Installation: Supply and install Clearview swing gate.
- 8. Gate Post Installation: Supply and install structural gate posts for the swing gate.

### 5. DURATION

Commence work immediately after appointment and the project period will not exceed **THREE** (3) MONTHS.

- 1.5 Failure on the part of a tenderer to submit proof or documentation required in terms of this tender to claim points for specific goals with the tender, will be interpreted to mean that preference points for specific goals are not claimed.
- 1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

### 2. **DEFINITIONS**

- (a) **"tender"** means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation;
- (b) "**price**" means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts;
