1. PROJECT PURPOSE

The purpose of this Request for Quotation (RFQ) is to invite suitably qualified and experienced service providers to submit quotations for the **transportation of Household goods/furniture from The Junction Apartments, Centurion, Pretoria to West Acres, Mbombela**. The appointed service provider will be responsible for the safe, secure, and timely collection, transport, and delivery of the furniture in accordance with the specified requirements and agreed timelines.

2. SERVICE PROVIDER'S TERMS OF REFERENCE

The Mpumalanga Economic Growth Agency (MEGA) invites suitably qualified and experienced service providers to submit quotations for the transportation of household goods/furniture from **The Junction Apartments**, **Centurion**, **Pretoria to West Acres**, **Mbombela**.

A formal Service Level Agreement (SLA) will be entered into with the appointed service provider, outlining the scope of services, collection and delivery timelines, and all related responsibilities and obligations.

These Terms of Reference (ToR) serve as a framework for the evaluation and appointment process, ensuring alignment between MEGA's logistical requirements and the service provider's technical capacity, reliability, and compliance with the service standards. The successful bidder's proposal submitted in response to this RFQ will form the basis of the SLA to be concluded with MEGA.

3. PROPOSAL REQUIREMENTS

GENERAL SCOPE OF WORK

The appointed service provider will be responsible for the safe, secure, and timely transportation of household goods/furniture from **The Junction Apartments, Centurion, Pretoria to West Acres, Mbombela**. The items to be transported include, but is not limited to, the following:

- 263L Fridge with mirror door
- Washing machine
- King size bed
- 3-seater couch
- King size headboard
- 2 x Bar stools
- Coffee table small
- 40L Microwave
- TV and small speakers
- Miscellaneous small items (e.g, pots, bedding, etc.)

4. EXPECTED DELIVERABLES

The appointed service provider will be expected to deliver the following as part of the transportation services for household goods and furniture from Centurion, Pretoria to West Acres, Mbombela:

1. Safe Collection and Loading

- Collection of all listed items from the specified pickup address in Centurion.
- Proper handling, packaging (where necessary), and secure loading of all goods to prevent damage during transit.

2. Transportation of Items

Transport of the following items in a suitable, enclosed vehicle to ensure protection from weather and damage:

- 263L Fridge with mirror door
- Washing machine
- King size bed
- 3-seater couch
- King size headboard
- 2 x Bar stools
- Small coffee table
- 40L microwave
- TV and small speakers
- Miscellaneous small items (e.g., pots, bedding, etc.)

3. Secure Delivery and Offloading

- Timely delivery of all items to the designated location in West Acres, Mbombela.
- Careful offloading and placement of items in the specified area or room, as directed by the recipient.

4. Condition Assurance

- All goods must arrive in the same condition as collected, with no damages or losses.
- The service provider must take necessary precautions to secure fragile and high-value items (e.g., TV, fridge, and mirror doors).

5. **Delivery Confirmation**

• Submission of a signed delivery note confirming the successful delivery and acceptance of all listed items.

- 3.4 The terms of the accompanying bid have not been, and will not be, disclosed by the bidder, directly or indirectly, to any competitor, prior to the date and time of the official bid opening or of the awarding of the contract.
- 3.5 There have been no consultations, communications, agreements or arrangements made by the bidder with any official of the procuring institution in relation to this procurement process prior to and during the bidding process except to provide clarification on the bid submitted where so required by the institution; and the bidder was not involved in the drafting of the specifications or terms of reference for this bid.

PREFERENCE POINTS CLAIM FORM IN TERMS OF THE PREFERENTIAL PROCUREMENT REGULATIONS 2022

This preference form must form part of all tenders invited. It contains general information and serves as a claim form for preference points for specific goals.

- 1.5 Failure on the part of a tenderer to submit proof or documentation required in terms of this tender to claim points for specific goals with the tender, will be interpreted to mean that preference points for specific goals are not claimed.
- 1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

2. **DEFINITIONS**

- (a) **"tender"** means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation;
- (b) "**price**" means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts;
- (c) "rand value" means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;
- (d) "tender for income-generating contracts" means a written offer in the form determined by an organ of state in response to an invitation for the origination of income-generating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions; and
- (e) "**the Act**" means the Preferential Procurement Policy Framework Act, 2000 (Act No. 5 of 2000).

4. POINTS AWARDED FOR SPECIFIC GOALS

- 4.1. In terms of Regulation 4(2); 5(2); 6(2) and 7(2) of the Preferential Procurement Regulations, preference points must be awarded for specific goals stated in the tender. For the purposes of this tender the tenderer will be allocated points based on the goals stated in table 1 below as may be supported by proof/ documentation stated in the conditions of this tender:
- 4.2. In cases where organs of state intend to use Regulation 3(2) of the Regulations, which states that, if it is unclear whether the 80/20 or 90/10 preference point system applies, an organ of state must, in the tender documents, stipulate in the case of—
 - (a) an invitation for tender for income-generating contracts, that either the 80/20 or 90/10 preference point system will apply and that the highest acceptable tender will be used to determine the applicable preference point system; or
 - (b) any other invitation for tender, that either the 80/20 or 90/10 preference point system will apply and that the lowest acceptable tender will be used to determine the applicable preference point system,

then the organ of state must indicate the points allocated for specific goals for both the 90/10 and 80/20 preference point system.

 - (d) recommend that the tenderer or contractor, its shareholders and directors, or only the shareholders and directors who acted on a fraudulent basis, be restricted from obtaining business from any organ of state for a period not exceeding 10 years, after the *audi alteram partem* (hear the other side) rule has been applied; and
