1. PROJECT PURPOSE

The purpose of this Request for Quotation (RFQ) is to invite suitably qualified and experienced service providers to submit quotations for the supply and delivery of an ergonomic high back-office chair. The appointed service provider will be expected to deliver a high-quality product that meets the specified ergonomic and design standards, within the agreed timelines.

2. SERVICE PROVIDER'S TERMS OF REFERENCE

The Mpumalanga Economic Growth Agency (MEGA) invites suitably qualified and experienced service providers to submit quotations for the supply and delivery of an ergonomic high back-office chair.

A formal Service Level Agreement (SLA) will be entered into with the appointed service provider, detailing the scope of supply, product specifications, delivery timelines, and associated obligations.

These Terms of Reference (ToR) provide a framework for the evaluation and appointment process, ensuring alignment between MEGA's requirements and the service provider's technical capability, product quality, and compliance with the specifications. The successful bidder's proposal submitted in response to this RFQ will form the basis of the SLA concluded with MEGA.

3. PROPOSAL REQUIREMENTS

GENERAL SCOPE OF WORK

The appointed service provider will be responsible for the supply and delivery of a **high-quality ergonomic high back-office chair** that meets the required specifications set out in this RFQ. The general scope of work includes, but is not limited to, the following:

3.1 Product Specifications

- Supply one (1) ergonomic high back-office chair suitable for extended office use.
- The chair must be adjustable (height, armrests, and backrest) and designed to support proper posture and comfort.
- The product must be manufactured from durable, high-quality materials with a professional finish.

3.2 Delivery Requirements

- Ensure safe and timely delivery of the chair to MEGA's designated office location.
- The chair must be delivered fully assembled.
- Delivery must occur within the timeline specified in the RFQ.

3.3 Warranty and Support

- The product must carry a manufacturer's warranty.
- The service provider must provide after-sales support, including assistance with warranty claims and product defects.

3.4 Compliance and Quality Assurance

- All items must be new, unused, and free from defects in materials and workmanship.

3.5 Documentation

- Provide all necessary documentation, including product manuals, warranty certificates, and delivery notes upon completion of the delivery.

4 EXPECTED DELIVERABLES

The appointed service provider is expected to deliver the following:

4.1 Ergonomic High Back-Office Chair

- One (1) fully functional ergonomic high back-office chair that meets all the specified requirements, including:
 - Adjustable height, armrests, and lumbar support
 - High backrest with proper ergonomic design
 - Durable and high-quality materials
 - Professional office-grade finish

4.2 On-Time Delivery

- Delivery of the chair to the designated MEGA office location within the agreed timeframe as specified in the Service Level Agreement (SLA).

4.3 Product Documentation

- User manual and assembly instructions (if applicable)
- Warranty certificate(s)

4.4 Delivery Note

- A signed delivery note confirming successful delivery and acceptance of the chair.

4.5 Warranty and After-Sales Support

- Product warranty
- Contact details for after-sales support in the event of product defects or warranty claims

- 3.4 The terms of the accompanying bid have not been, and will not be, disclosed by the bidder, directly or indirectly, to any competitor, prior to the date and time of the official bid opening or of the awarding of the contract.
- 3.5 There have been no consultations, communications, agreements or arrangements made by the bidder with any official of the procuring institution in relation to this procurement process prior to and during the bidding process except to provide clarification on the bid submitted where so required by the institution; and the bidder was not involved in the drafting of the specifications or terms of reference for this bid.

PREFERENCE POINTS CLAIM FORM IN TERMS OF THE PREFERENTIAL PROCUREMENT REGULATIONS 2022

This preference form must form part of all tenders invited. It contains general information and serves as a claim form for preference points for specific goals.

1. GENERAL CONDITIONS

1.1 The following preference point systems are applicable to invitations to tender:

- the 80/20 system for requirements with a Rand value of up to R50 000 000 (all applicable taxes included); and
- the 90/10 system for requirements with a Rand value above R50 000 000 (all applicable taxes included).

1.2 To be completed by the organ of state

- a) The applicable preference point system for this tender is the **80/20** preference point system.

1.3 Points for this tender (even in the case of a tender for income-generating contracts) shall be awarded for:

- 1.5 Failure on the part of a tenderer to submit proof or documentation required in terms of this tender to claim points for specific goals with the tender, will be interpreted to mean that preference points for specific goals are not claimed.
- 1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

2. DEFINITIONS

- (a) **“tender”** means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation;
- (b) **“price”** means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts;
- (c) **“rand value”** means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;
- (d) **“tender for income-generating contracts”** means a written offer in the form determined by an organ of state in response to an invitation for the origination of income-generating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions; and
- (e) **“the Act”** means the Preferential Procurement Policy Framework Act, 2000 (Act No. 5 of 2000).

3.1. POINTS AWARDED FOR PRICE

3.2.1. POINTS AWARDED FOR PRICE

A maximum of 80 or 90 points is allocated for price on the following basis:

4. POINTS AWARDED FOR SPECIFIC GOALS

- 4.1. In terms of Regulation 4(2); 5(2); 6(2) and 7(2) of the Preferential Procurement Regulations, preference points must be awarded for specific goals stated in the tender. For the purposes of this tender the tenderer will be allocated points based on the goals stated in table 1 below as may be supported by proof/ documentation stated in the conditions of this tender:
- 4.2. In cases where organs of state intend to use Regulation 3(2) of the Regulations, which states that, if it is unclear whether the 80/20 or 90/10 preference point system applies, an organ of state must, in the tender documents, stipulate in the case of—
- (a) an invitation for tender for income-generating contracts, that either the 80/20 or 90/10 preference point system will apply and that the highest acceptable tender will be used to determine the applicable preference point system; or
 - (b) any other invitation for tender, that either the 80/20 or 90/10 preference point system will apply and that the lowest acceptable tender will be used to determine the applicable preference point system,
- then the organ of state must indicate the points allocated for specific goals for both the 90/10 and 80/20 preference point system.

 - (c) cancel the contract and claim any damages which it has suffered as a result of having to make less favourable arrangements due to such cancellation;
 - (d) recommend that the tenderer or contractor, its shareholders and directors, or only the shareholders and directors who acted on a fraudulent basis, be restricted from obtaining business from any organ of state for a period not exceeding 10 years, after the *audi alteram partem* (hear the other side) rule has been applied; and
 - (e) forward the matter for criminal prosecution, if deemed necessary.
