1. GENERAL CONDITIONS OF THE RFQ:

- 1.1. The 80/20 evaluation criteria for requirements with a Rand value of up to R50 000 000 (all applicable taxes included) will be used for this bid.
- 1.2. The value of this bid is estimated not exceed R1 000 000.00 (all applicable taxes included).

1. SCOPE OF THE REQUIRED SYSTEM

The bidder must provide a **fully developed and commercially available Board Management System** designed to support secure digital board and committee meetings, document management, and decision tracking.

Failure to meet **any mandatory requirement below will result in automatic disqualification.**

1.1. Platform Accessibility

The system must:

- a). Be accessible through **native applications** on the following platforms:
 - iOS (iPad and iPhone)
 - Android tablets and phones
 - Windows devices (Surface / laptops)
 - Web browser interface for administrative users
- b). The bidder must provide **proof of native applications available in official app stores** (Apple App Store, Google Play, Microsoft Store).

1.2. Security and Compliance

The system must meet **enterprise-grade security standards** and bidders must submit verifiable proof.

Mandatory security requirements include:

- a). **End-to-end AES-256 encryption** for data in transit and at rest.
- b). Valid **ISO 27001 Information Security Certification** for the solution provider.
- c). Compliance with recognized security frameworks such as:
 - ISO 27001
 - SOC 2 Type II or equivalent (preferred)
- d). **Multi-factor authentication (MFA)** including:
 - Password authentication

- f). Full **audit trail and activity logging** for all users.
- g). Compliance with **corporate IT password policies and device management controls.**

1.3. Core Board Management Functionality

The system must provide a **fully integrated board governance solution** including the following core functionality:

- a). Secure **agenda creation and board pack compilation.**

- b). **Instant distribution of confidential board papers** to authorized users.
- c). **Offline access capability** allowing directors to read and annotate documents without internet connectivity.
- d). **Agenda-based voting and circular resolutions**, including sequential approvals.
- e). **User access control** at multiple levels including:
 - i. User level
 - ii. Meeting level
 - iii. Document level

- f). **Annotations and collaboration tools** including:
 - i. Document highlighting
 - ii. Notes and comments
 - iii. Private and shared annotations

- g). **Meeting minutes management** including:
 - i. Recording of discussions
 - ii. Assignment and tracking of action items
 - iii. Automated follow-ups

- h). **Advanced search capability** across:
 - i. Minutes
 - ii. Agenda topics
 - iii. Historical meeting documents

1.4. Integration and Interoperability

The system must support integration with common enterprise tools including:

The system must allow secure storage and organization of governance documents including:

The solution must allow **custom categorization and structured document storage**.

1.6. Scalability

The solution must support **scalable deployment** with the ability to support:

- Without degradation of performance.**

1.7. Support and Service

The bidder must provide:

This preference form must form part of all tenders invited. It contains general information and serves as a claim form for preference points for specific goals.

1. GENERAL CONDITIONS

1.1 The following preference point systems are applicable to invitations to tender:

- the 80/20 system for requirements with a Rand value of up to R50 000 000 (all applicable taxes included); and
- the 90/10 system for requirements with a Rand value above R50 000 000 (all applicable taxes included).

1.2 **To be completed by the organ of state**

- 1.5 Failure on the part of a tenderer to submit proof or documentation required in terms of this tender to claim points for specific goals with the tender, will be interpreted to mean that preference points for specific goals are not claimed.
- 1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

2. DEFINITIONS

- (a) **“tender”** means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation;
- (b) **“price”** means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts;
- (c) **“rand value”** means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;
- (d) **“tender for income-generating contracts”** means a written offer in the form determined by an organ of state in response to an invitation for the origination of income-generating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions; and
- (e) **“the Act”** means the Preferential Procurement Policy Framework Act, 2000 (Act No. 5 of 2000).

3.2. FORMULAE FOR DISPOSAL OR LEASING OF STATE ASSETS AND INCOME GENERATING PROCUREMENT

3.2.1. POINTS AWARDED FOR PRICE

A maximum of 80 or 90 points is allocated for price on the following basis:

4. POINTS AWARDED FOR SPECIFIC GOALS

- 4.1. In terms of Regulation 4(2); 5(2); 6(2) and 7(2) of the Preferential Procurement Regulations, preference points must be awarded for specific goals stated in the tender. For the purposes of this tender the tenderer will be allocated points based on the goals stated in table 1 below as may be supported by proof/ documentation stated in the conditions of this tender:
- 4.2. In cases where organs of state intend to use Regulation 3(2) of the Regulations, which states that, if it is unclear whether the 80/20 or 90/10 preference point system applies, an organ of state must, in the tender documents, stipulate in the case of—
- (a) an invitation for tender for income-generating contracts, that either the 80/20 or 90/10 preference point system will apply and that the highest acceptable tender will be used to determine the applicable preference point system; or
 - (b) any other invitation for tender, that either the 80/20 or 90/10 preference point system will apply and that the lowest acceptable tender will be used to determine the applicable preference point system,
