1.1 SCOPE OF WORK

1.1.1 The service provider will be required to deliver on the following:

- a) Design and Layout of the annual report (AR) and annual financial statements (AFS), taking into account the specified theme and the MEGA corporate identity guidelines.
- b) Editing and proof-reading of the content to ensure consistency of language style and appropriate use of language.
- c) Packaging, printing and production – including use of the specified paper; managing and taking accountability of the printing process as well as delivery of the AR and AFS; the formatting and packaging of the report for electronic delivery.
- d) Production, designing, layout, editing, proof reading and translation of the AFS printed document.

1.1.2 Design and Typesetting Design (layout):

- a) A word document will be supplied by MEGA for the AR whilst either a pdf or excel document will be supplied for the AFS.
- b) The successful bidder will be expected to thoroughly edit all the content provided. MEGA will be responsible for the final sign-off of the designed report.
- c) Design and typesetting will be done on edited and approved text, with at least three (2) alternative designs to be forwarded to MEGA.
- d) A soft copy will be provided to MEGA for final approval.
- e) The following must be noted:
 - **Format:** A4
 - **Extent:** 4 cover pages and 260 inside pages
 - Successful service provider will be responsible for providing illustrative images whilst MEGA shall be responsible for supplying photos of the executives, board and its projects.
 - MEGA shall be responsible for providing its corporate identity manual and logo.

f) Hard Copies:

The specifications for the paper, printing and binding of the AR and AFS are the following:

- **Cover:** Four (4) pages 250gsm Matt.
- **Inside Paper & text:** 264 pages on 115gsm gloss.
- **Binding:** PUR Binding.
- **Colour:** Full colour throughout.
- **Printed Quantity:** 200 hard copies printed in one batch.

1.1.3 The successful service provider shall also be expected to effect all changes received from the Head: Corporate Strategy from time to time until approval of final printing. Bidders must factor in fourteen (14) drafts and one (1) final document.

1.2 EVALUATION CRITERIA

The tender will be evaluated in three (3) phases:

PHASE 1: ADMINISTRATIVE COMPLIANCE (MANDATORY – ELIMINATING)

Bidders must submit the following mandatory documents listed above. Failure to submit any mandatory document will result in automatic disqualification.

- Minimum of 2 recommendation letters from similar completed projects
- Minimum of 2 Artwork (only cover pages) from previous work completed
- Completed pricing structure according to format provided

PHASE 2: FUNCTIONALITY EVALUATION

Minimum Threshold: 70 points out of 100

Only bidders scoring 70 or above will proceed to Phase 3.

PHASE 3: PRICE AND SPECIFIC GOALS

Evaluation will be conducted using the 80/20

Preference Point System in terms of the Preferential Procurement Regulations 2022.

- 3.5 There have been no consultations, communications, agreements or arrangements made by the bidder with any official of the procuring institution in relation to this procurement process prior to and during the bidding process except to provide clarification on the bid submitted where so required by the institution; and the bidder was not involved in the drafting of the specifications or terms of reference for this bid.

**PREFERENCE POINTS CLAIM FORM IN TERMS OF THE PREFERENTIAL

This preference form must form part of all tenders invited. It contains general information and serves as a claim form for preference points for specific goals.

1. GENERAL CONDITIONS

1.1 The following preference point systems are applicable to invitations to tender:

- the 80/20 system for requirements with a Rand value of up to R50 000 000 (all applicable taxes included); and
- the 90/10 system for requirements with a Rand value above R50 000 000 (all applicable taxes included).

1.2 To be completed by the organ of state

a) The applicable preference point system for this tender is the 80/20 preference point system.

1.3 Points for this tender (even in the case of a tender for income-generating contracts) shall be awarded for:

- (a) Price; and
- (b) Specific Goals.

- 1.5 Failure on the part of a tenderer to submit proof or documentation required in terms of this tender to claim points for specific goals with the tender, will be interpreted to mean that preference points for specific goals are not claimed.
- 1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

2. DEFINITIONS

- (a) **“tender”** means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation;
- (b) **“price”** means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts;
- (c) **“rand value”** means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;
- (d) **“tender for income-generating contracts”** means a written offer in the form determined by an organ of state in response to an invitation for the origination of income-generating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions; and
- (e) **“the Act”** means the Preferential Procurement Policy Framework Act, 2000 (Act No. 5 of 2000).

3.2. FORMULAE FOR DISPOSAL OR LEASING OF STATE ASSETS AND INCOME GENERATING PROCUREMENT

3.2.1. POINTS AWARDED FOR PRICE

A maximum of 80 or 90 points is allocated for price on the following basis:

4. POINTS AWARDED FOR SPECIFIC GOALS

- 4.1. In terms of Regulation 4(2); 5(2); 6(2) and 7(2) of the Preferential Procurement Regulations, preference points must be awarded for specific goals stated in the tender. For the purposes of this tender the tenderer will be allocated points based on the goals stated in table 1 below as may be supported by proof/ documentation stated in the conditions of this tender:
- 4.2. In cases where organs of state intend to use Regulation 3(2) of the Regulations, which states that, if it is unclear whether the 80/20 or 90/10 preference point system applies, an organ of state must, in the tender documents, stipulate in the case of—
- (a) an invitation for tender for income-generating contracts, that either the 80/20 or 90/10 preference point system will apply and that the highest acceptable tender will be used to determine the applicable preference point system; or
 - (b) any other invitation for tender, that either the 80/20 or 90/10 preference point system will apply and that the lowest acceptable tender will be used to determine the applicable preference point system,

then the organ of state must indicate the points allocated for specific goals for both the 90/10 and 80/20 preference point system.

 - (c) cancel the contract and claim any damages which it has suffered as a result of having to make less favourable arrangements due to such cancellation;
 - (d) recommend that the tenderer or contractor, its shareholders and directors, or only the shareholders and directors who acted on a fraudulent basis, be restricted from obtaining business from any organ of state for a period not exceeding 10 years, after the *audi alteram partem* (hear the other side) rule has been applied; and
 - (e) forward the matter for criminal prosecution, if deemed necessary.
