4. SCOPE OF WORK

The appointed Quantity Surveyor will be required to perform the following functions on:

4.1 BUILDING ASSESSMENT

- Conduct site inspections of all identified factory buildings.
- Assess structural integrity, roofing, walls, floors, windows and other necessary finishes.
- Evaluate electrical installations and water supply services.
- Evaluate mechanical installations where necessary.
- Identify damages due to vandalism, wear and tear, and environmental factors.
- Evaluate security features within each factory.
- Evaluate fire protection services/systems (i.e., hose reels, sprinklers, fire extinguishers, etc.)

4.2 PREPARATION OF BILLS OF QUANTITIES (BOQ'S)

- Develop comprehensive BOQ's for repair, refurbishment, and upgrade works.
- Clearly define material specifications (i.e., breakers, etc.) and workmanship standards.
- Provide itemized quantities with accurate measurements.

4.3 COST ESTIMATE AND BUDGETING

- Prepare detailed cost estimates based on prevailing market rates.
- Provide a cost breakdown per building or factory.
- Include contingency provisions where applicable.

- Compile a detailed assessment report including findings, photographs, and recommendations.

- Provide professional advice on cost optimization.

5. PROCUREMENT STRATEGY AND FINANCIAL IMPLICATIONS.

The Quantity Surveyor will be appointed in accordance with the organization's procurement policies and procedures, which may include:

- Request for Bids (RFB) from qualified and registered QS professionals.
- Evaluation based on experience, capacity, and cost competitiveness.
- Verification of professional registration (e.g., SACQSP or relevant authority).

The appointment of a Quantity Surveyor will incur professional service fees, which will be sourced/funded from the allocated project budget. This will ensure:

- More accurate budgeting for rehabilitation projects.
- Improved cost control during project execution.
- Informed decision-making regarding funding allocation.

- 7.3. Quotations to be accompanied by **8 referral letters** of similar work which will be verified upon receiving them.

- 3.4 The terms of the accompanying bid have not been, and will not be, disclosed by the bidder, directly or indirectly, to any competitor, prior to the date and time of the official bid opening or of the awarding of the contract.
- 3.5 There have been no consultations, communications, agreements or arrangements made by the bidder with any official of the procuring institution in relation to this procurement process prior to and during the bidding process except to provide clarification on the bid submitted where so required by the institution; and the bidder was not involved in the drafting of the specifications or terms of reference for this bid.

PREFERENCE POINTS CLAIM FORM IN TERMS OF THE PREFERENTIAL PROCUREMENT REGULATIONS 2022

This preference form must form part of all tenders invited. It contains general information and serves as a claim form for preference points for specific goals.

1. GENERAL CONDITIONS

1.1 The following preference point systems are applicable to invitations to tender:

1.2 To be completed by the organ of state

- 1.5 Failure on the part of a tenderer to submit proof or documentation required in terms of this tender to claim points for specific goals with the tender, will be interpreted to mean that preference points for specific goals are not claimed.
- 1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

2. DEFINITIONS

- (a) **“tender”** means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation;
- (b) **“price”** means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts;
- (c) **“rand value”** means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;
- (d) **“tender for income-generating contracts”** means a written offer in the form determined by an organ of state in response to an invitation for the origination of income-generating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions; and
- (e) **“the Act”** means the Preferential Procurement Policy Framework Act, 2000 (Act No. 5 of 2000).

4. POINTS AWARDED FOR SPECIFIC GOALS

- 4.1. In terms of Regulation 4(2); 5(2); 6(2) and 7(2) of the Preferential Procurement Regulations, preference points must be awarded for specific goals stated in the tender. For the purposes of this tender the tenderer will be allocated points based on the goals stated in table 1 below as may be supported by proof/ documentation stated in the conditions of this tender:
- 4.2. In cases where organs of state intend to use Regulation 3(2) of the Regulations, which states that, if it is unclear whether the 80/20 or 90/10 preference point system applies, an organ of state must, in the tender documents, stipulate in the case of—
- (a) an invitation for tender for income-generating contracts, that either the 80/20 or 90/10 preference point system will apply and that the highest acceptable tender will be used to determine the applicable preference point system; or
 - (b) any other invitation for tender, that either the 80/20 or 90/10 preference point system will apply and that the lowest acceptable tender will be used to determine the applicable preference point system,

 - (c) cancel the contract and claim any damages which it has suffered as a result of having to make less favourable arrangements due to such cancellation;
 - (d) recommend that the tenderer or contractor, its shareholders and directors, or only the shareholders and directors who acted on a fraudulent basis, be restricted from obtaining business from any organ of state for a period not exceeding 10 years, after the *audi alteram partem* (hear the other side) rule has been applied; and
